The following resolutions passed by the Governing Body.

The Principal In-charge of the College Dr. M. Swarupa Rani extended cordial welcome to the Governing Body members of the meeting.

With the permission of the Chair Dr. Y. Syamamma Director of the college presented the Agenda for discussion.

Item No.1 Implementation of action taken on the previous meeting advices.

- a) On the request of the Principal Incharge Dr. M. Swaruparani, the Director Dr. Y. Syamamma gave powerpoint presentation on developments and achievements of the college before the committee. They advised to give more information about the class- wise students strength and results.
- b) The second advice was discussed and passed resolution in Item No.8.
- c) The committee suggested that two meetings should be conducted in a year. In previous meetings, it is implemented in this year so the first meeting was conducted on 26.7.14 and the second meeting will be conducted in January 2015.
- d) The fourth suggestion was taken up for implementation. It was discussed and resolutions were passed in item No.7.

Item No.2 : Approval of minutes of the meeting held on 5.11.2013.

The fourth meeting of D.R.W. College (Autonomous) Gudur was held on 5.11.2013.

The Principal of the College Dr. M. Swaruparani presented the minutes of the previous meeting for its approval (Annexure- I) The Governing Body while approving the same. The honourable members from UGC Dr. K. Gunasekaran and Educationist Dr. I. Gopal Reddy suggested to re arrange the Agenda as the Item No.1 is "Approval of the minutes of the previous meeting" in order of preference. The suggestion will be followed in future and also suggested that the minutes of the previous meeting should be circulated to all the committee members before commitment of Governing Body members.

Item No.3 : Implementing the Autonomous status with regard to UG and PG Courses

The report submitted on the implementation of Autonomous status by the Principal the Chairperson of the Academic Council, has been recorded as reported item.

Item No.4 : Conduct of Examinations

The report submitted on the conduct of examinations has been recorded as reported item. As per the suggestions of the Governing Body members in previous meetings, the Asst. Controller of Examinations attended the meeting as special invitees and submitted detailed information about results and benefited students through instant examinations.

Item No.5 : Fixation of fee and other charges payable by the students of the college on the recommendations of the Finance Committee.

The examination fee structure recommended by the finance committee and approved by the academic council is ratified. As per the advice of the Governing Body members in previous meeting, the details of fee structure was submitted in the meeting.

Item No.6 : Instituting Scholarships, Medals and Prizes

The committee appreciated the Management and the teaching staff for presented 34 gold medals to the best outgoing students. The report submitted on instituting gold medals from the interest on Fixed deposits every year has been recorded as reported item.

Item No.7: Change of Nomenclature of Two UGC Innovative Programmes

The Governing body members unanimously approved the recommendations of the academic council to change the Nomenclature of two innovative programmes in M.A. Corporate Telugu into M.A. Telugu (Corporate) and M.Sc., Human Nutrition and Nutraceutical Chemistry into M.Sc., Home Science (HNNC) which is beneficent to the students to appearing for NET & SLET examinations and receiving various jobs.

Item No.8: Introducing CBCS to all I Degree & PG Students

Governing Body suggested the introduction of CBCS to all the core subjects in future after deep observation of CBCS system at various colleges. Governing Body resolved to introduce General Mathematics, Reasoning and optional papers to all I degree students in elective paper.

Item No.9 : Approval of proposals of the Boards of Studies concerned.

The recommendations made by the Board of studies concerned were approved by the Academic Council in the meeting held on 26.7.2014 at 10 A.M. The same is re generate as reported item. The Governing Body suggested that 62.5% attendance should be made compulsory to write Semester End Examinations. Take declaration from students and also this should be mentioned in the prospectus.

Item No.10 Any other Matter


The report submitting the conduct of convocation has been recorded as reported item. The Management and teaching staff organized the Ist convocation successfully.
