**Item No.1 : Approval of Minutes of the Meeting held on 29.10.2011**

**Item No.2 Implementation of Autonomous Status with regard to UG and PG Courses**

**Item No.3 : Conduct of Examinations.**

The College will be completing three years of Autonomous status and will conduct the three year Degree examinations during March 2013. To facilitate the students to save the year ,it has been proposed to conduct Instant Examinations during second week of May 2013. The following will be the eligible criteria for appearing the Instant Examination.

The final year students who have balance of three papers in the three years ( i.e. First, Second and Final year ) are eligible to appear for instant examinations.

The item was discussed in the Academic council Meeting held on 12.9.2012 and the committee unanimously recommended the same to Governing Body for its approval.

**Item No.4 : Fixation of Fee and other charges payable by the students of the College on the recommendations of the Finance Committee.**

The examination fee structure recommended by the Finance Committee and approved by the Academic Council is ratified.

**Item No. 5 : Instituting Scholarships, Medals and Prizes.**

The medals proposed to be instituted from the year 2011-2012 for the Best outgoing students in M. Sc., Mathematics, Physics, Chemistry, Biotechnology and M.A. Corporate Telugu will be continued.


